### ENTRIES

For Italian competitors, the entries can be insert online to the official ACI SPORT Italian Motorsport Federation website only.

For foreigners competitors use the entry form found on the our website and send to [info@scuderiaredwhite.com](mailto:info@scuderiaredwhite.com)

The organizer will insert the foreign competitors entries on the ACI SPORT website.

### ADMINISTRATIVE CHECKS - FORMS AND DOCUMENTS

In order to ensure compliance with the health regulations in force regarding the containment of the spread of the COVID-19 virus, **ADMINISTRATIVE CHECKS ARE CANCELED**, replaced by the online registration procedure and the completion of the following mandatory forms (new or already present in previous years) to be presented to the **ACCREDITATION OFFICE** at the entrance to the reserved Paddock area, or to be sent by email to [info@scuderiaredwhite.com](mailto:info@scuderiaredwhite.com)

**To be delivered by hand at the Accreditation Center.**

1. Self-declaration about possession driving license.
2. COVID risk self-declaration signed in original or EU digital COVID certificate for each of the team members.

**To be sent by email to [info@scuderiaredwhite.com](mailto:info@scuderiaredwhite.com)  
before entries closing.**

3. Team member list form.
4. Paddock area request form.
5. Self-certification of previous years results

### 6. Copy of the licenses with the renewal / expiration date.

## TECHNICAL SCRUTINEERING - FORMS AND DOCUMENTS

In order to ensure compliance with the health regulations in force regarding the containment of the spread of the COVID-19 virus, the TECHNICAL SCRUTINEERING are replaced by delivery at the entrance of the car in the paddock area, Accreditation Center, in the presence of one or more Technical Stewards, of these forms:

### To be delivered by hand to the Accreditation Center - Technical Area

1. Declaration of safety clothing conformity.
2. Conformity's declaration of the vehicle safety's devices. The form must refer to the group it belongs to.
3. Copy of identity document with original signature.

In the area of the site dedicated to Competitors you will find instructions for completing the technical declarations / certifications and all the forms.

To simplify, we have proceeded to insert the conformity's declarations of the vehicle safety's devices already divided by the groups to which they belong.

The Scrutineers may decide at their discretion to carry out pre-race checks on any car in the Paddock assigned area.

## ACCREDITATION OFFICE PADDOCK ACCESS RESTRICTED AREA

**ACCREDITATION OFFICE** times, restricted area as indicated in the Supplementary Regulations:

- Friday 1<sup>st</sup> October from 10.30 to 19.00

**STARTING PARK** (Paddock, restricted area) entrance times as indicated in the Supplementary Regulations:

- Saturday 2<sup>nd</sup> October at 08.00
- Sunday 3<sup>rd</sup> October at 08.00

At the entrance of the cars, the manager, referent of team will deliver the documentation listed in the previous pages.

1. **Access allowed only to people wearing the wristband.**
2. **Measurement of body temperature at the entrance.**
3. **Obligation to always wear a mask, to maintain social distancing.**  
Entry will not be allowed to people without individual protection systems.

## START ALIGNMENT

Access allowed only to the Driver with the race car and to 1 Mechanic with the appropriate wristband.
